## **Prosecutor – Introductory Statement to the Jury**

Thank you for your willingness to serve on the jury of this most important case, one of the most important in the history of our nation.

You have heard the evidence presented by the government every day from government representatives and the mainstream media, that:

- COVID-19 is a deadly killer virus that has caused a terrible pandemic, taken tens of thousands of lives, and necessitated the most severe lockdowns and restrictions on the American people to stop the virus, all for our own good,
- we need to “embrace science” by all wearing masks, keeping social distance, curtailing meeting with groups and in churches, and taking the vaccine as soon as it is available, so we can get back to normal as soon as possible,
- we can thank the pharmaceutical industry for rising to the challenge with the rapid development and quick rollout of vaccines that will save lives, and restore our economy and our nation, and
- the mainstream media and social media tech giants are doing their best to keep us informed about this killer virus in spite of a great deal of

**misinformation floating around on the internet from anti-vaxxers and conspiracy theorists.**

In contrast to this official story, I will present evidence that at the same time that many dedicated leaders and health care providers are doing the best they can to deal with COVID-19 and protect the American people, there is an underlying reality that becomes apparent when we look more closely: that although the virus is real, COVID-19 has been blown out of proportion to create fear in the American public and justify masks, social distancing, lockdowns, and vaccines for financial, political, and globalist purposes.

**I would encourage you to look at the evidence presented with an open, but critical mind, questioning everything (including the official story from the government, recommendations from your friends and family doctor, and the evidence presented below), and come to your own conclusions.**

Most of us have had positive experiences with vaccines, and recall how vaccines have been effective for polio and other diseases in the past. But it is important for us to set aside our pre-conceived ideas about the value of vaccines, because **COVID-19 vaccines are like no other vaccine. They:**

- **have ingredients never used before in vaccines,**
- **were never tested with animals (the traditional standard requirement for vaccine development),**
- **are still experimental,**
- **have questionable effectiveness,**
- **are generating serious side effects, including some deaths,**
- **have no long-term studies (so we really don't know their long-term consequences),**
- **change (“augments, enhances, and reprograms”) our human DNA,**
- **contain nanobot technologies and DNA from animals,**
- **create no legal liability for the manufacturers, and**
- **don't even meet the medical definition of a vaccine.**

This is also not about conservative vs. liberal, Republican vs. Democrat, or any other social measure. It is about what is really true and what is false.

The following is an attempt to present FACTS to you (the jury), so you can make up your own mind. I anticipate there will be more viruses and vaccines in the future, but this will focus on COVID-19. **Although new vaccines are now being approved, this document will focus on the two most common vaccines now being used – those manufactured by Moderna and Pfizer, which are mRNA based.** By the way, aborted fetus tissue is used in testing these vaccines, while AstraZeneca and Johnson and Johnson include aborted fetus tissue in their vaccines.

The government and Dr. Fauci (the national spokesmen for COVID-19 policy) all claim to be “pro-science”. Fine – so let’s look at what they are promoting and compare them with the documents below, which are sourced from their own government databases and websites, from peer-reviewed scientific publications, from medical professionals and scientists all over the world, and a few carefully confirmed news stories.

I would add that Facebook, the pharmaceutical industry, and government regulators like Dr. Fauci use the term ‘vaccine misinformation’ as a euphemism for any assertion that departs from official pronouncements about vaccine health and safety, whether true or not. Furthermore, the mainstream media and social media giants are imposing a censorship to prevent civil informed debate in the public square.

So question everything and always seek the truth, for it will set us free.

## **Statement: There Would be no “Pandemic” With COVID-19 if the World Health Organization Had Not Changed the Definition of a Pandemic.**

- Had it not been for the World Health Organization changing the definition of “pandemic,” COVID-19 would no longer be an issue. The WHO’s original definition of a pandemic specified simultaneous epidemics worldwide “with enormous numbers of deaths and illnesses”.
- This definition was changed in the month leading up to the 2009 swine flu pandemic. The WHO removed the severity and high mortality criteria, leaving the definition of a pandemic as “a worldwide epidemic of a disease”.
- Now, nine months into the pandemic, mortality statistics clearly show the truth: The COVID-19 pandemic is a pandemic in name only. In reality, there's no excess mortality, and had it not been for the World Health Organization changing the definition of "pandemic," COVID-19 would no longer be an issue.
- We now have plenty of data showing the lethality of COVID-19 is on par with the seasonal flu. It may be different in terms of symptoms and complications, but the actual lethality is about the same.

- “Four German holidaymakers who were illegally quarantined in Portugal after one was judged to be positive for Covid-19 have won their case, in a verdict that condemns the widely-used PCR test as being up to 97 percent unreliable.
- The Portuguese judges cited a study conducted by “some of the leading European and world specialists,” which was published by Oxford Academic at the end of September. ## Smoking Gun: Fauci states COVID test has Fatal Flaw; Confession from the "Beloved" Expert of Experts



## Total flu deaths suspiciously dropped to zero for the 2020-2021 flu season.

- We don't hear much in the news about the tens of thousands of people dying each year from the flu, so most of us don't realize how deadly it is. As shown in the chart below, total annual worldwide flu deaths consistently exceeded 50,000 people in 2017, 2018 and again in 2019, but strangely dropped to zero starting in early 2020 and have remained there ever since. **Antigen Tests Also Have Questionable Validity - After mounting evidence, FDA, CDC now admit that coronavirus tests are faulty**

- “On Nov. 3, the FDA released new guidelines for rapid antigen testing for COVID-19 that acknowledged a high likelihood of incorrect results.
- The FDA stated that the accuracy of rapid tests depends almost totally on the amount of COVID-19 in the population being tested, stating: “As disease prevalence decreases, the percent of test results that are false positives increase.”

- The agency added that ‘in a population with only a one percent prevalence, only 30 percent of those who test positive for the disease would actually have it.’ [i.e. 70% of those who test positive would be false positives.]
- The CDC has echoed the FDA’s recommendations. It stated ‘Antibody test results should not be used to determine if someone can return to work,’ the CDC stated, adding that this also applied to schools, dormitories and even correctional facilities.
- People who receive positive results on an antibody test but don’t have symptoms of COVID-19 and have not been around someone who may have COVID-19 are not likely to have a current infection,’ the agency explained, stating that these people can ‘continue with normal activities.’
- A study published in the *Journal of Clinical Microbiology* found that rapid [antigen] tests with a 98 percent specificity used in American schools could result in over 800,000 false-positive results every week.

Furthermore, if a person diagnosed as having COVID-19 has early and sound treatment, their odds of survival would be even better than the odds above.

### Problems with the COVID-19 Vaccine

Moderna vaccine in January. She had consulted with two obstetrics and gynecologists (OB-GYN) prior to receiving the vaccine on Jan. 14. She experienced abdominal cramping and vaginal bleeding two days later and had a miscarriage on Jan. 19. She had only been taking prenatal vitamins.

## 46 Residents in Spanish Nursing Home Die After Receiving COVID-19 Vaccine

## How Effective is the COVID Vaccine? NOT SO EFFECTIVE

- Moderna claimed its vaccine is 95% effective. Actually, the vaccine is not really 95% effective at stopping the virus; it is simply 95% better than the placebo from not having symptoms.”

Dr. Chris Beyrer, Infectious Disease Epidemiologist, states: ‘We don't know if they [the vaccines] prevent transmitting the disease’.

A Pfizer spokesperson states: ‘We are likely to get something like the flu vaccine. It is not necessarily going to protect you from infection, and it may not work for everyone.’

These vaccines as they get approved cannot stop infection. There is no way to prove it, so therefore, even if your symptoms go away, all it has done is turn you into an asymptomatic carrier that you can spread to other people. So your mask won't come off because you have a vaccine.

But Slaoui said ‘10-15% of vaccine participants got the symptoms, so it was really 1,500 of the people who got the vaccine showed these symptoms, compared to 185 who had symptoms in the placebo group.’

So the placebo actually worked 90% better than the vaccine group at avoiding

### symptoms, and the vaccine made more people sick!!!


that she refused to take the vaccine because she wasn't convinced of its safety for pregnant woman. Lu is six months pregnant.


## **‘Perfectly Healthy’ Florida Doctor Dies Weeks After Getting Pfizer COVID Vaccine**

## **Tanzanian Government Skeptical About Safety of COVID-19 Vaccines**



### **51,971 Medical Practitioners and Public Health Scientists Sign the Great Barrington Declaration to Loosen Restrictions and Protect the Most Vulnerable**

- The Great Barrington Declaration was written from October 2 to October 4, 2020. It was signed on October 4, at the American Institute for Economic Research, located in Great Barrington, Massachusetts.

It was released to the public on October 5 (just 54 days ago), and since then has been signed by:

- 12,943 medical and public health scientists,
- 39,028 medical practitioners, and
- 702,598 concerned citizens.
- 754,569 people
- The Great Barrington Declaration: “As infectious disease epidemiologists and public health scientists we have grave concerns about the damaging physical and mental health impacts of the prevailing COVID-19 policies, and recommend an approach we call Focused Protection.
- Current lockdown policies are producing devastating effects on short and long-term public health.
- We know that vulnerability to death from COVID-19 is more than a thousand-fold higher in the old and infirm than the young.
- The most compassionate approach is to allow those who are at minimal risk of death to live their lives normally to build up immunity to the virus through natural infection, while better protecting those who are at highest risk. We call this Focused Protection, such as nursing homes using staff with acquired immunity and perform frequent PCR testing of other staff and all visitors.
- Those who are not vulnerable should immediately be allowed to resume life as normal. Simple hygiene measures, such as hand washing and staying home when sick should be practiced by everyone to reduce the herd immunity threshold.
  - Schools and universities should be open for in-person teaching.
  - Extracurricular activities, such as sports, should be resumed.
  - Young low-risk adults should work normally, rather than from home.
  - Restaurants and other businesses should open.
  - Arts, music, sport and other cultural activities should resume.”

## **Wearing Masks Causes Gum Disease, Which Increases Coronavirus Death Risk by 900%**

## **APPENDIX: 6 Questions to Ask Your Friends Who Plan to Get the Covid Vaccine**

Many of us have friends or family who plan on getting the vaccine. Maybe they truly believe they are in danger. Maybe they think it's better safe than sorry. Maybe they just want to be able to go to the pub again.

### **1. DID YOU KNOW THAT THEY HAVE NEVER SUCCESSFULLY VACCINATED PEOPLE AGAINST ANY CORONAVIRUS?**

No successful vaccine against a coronavirus has ever been developed.

Scientists have been trying to develop a SARS and MERS vaccine for years, with nothing to show for it. In fact, some of the failed SARS vaccines actually caused hypersensitivity to the SARS virus. **Meaning that vaccinated mice could potentially get the disease more severely than unvaccinated mice.**

NOTE: The Johnson and Johnson vaccine may be an exception, but it too has no long term studies, nor animal controls.

Vaccine development is a slow, laborious process. Usually, from development through testing and finally being approved for public use **takes many years**. The various vaccines for Covid have all been developed and approved in less than a year.

- Multisystem inflammatory syndrome,
- Chronic seizures and convulsions,
- Paralysis, including Bell's Palsy, and
- Miscarriages.

The USA's Public Readiness and Emergency Preparedness Act (PREP) grants immunity until at least 2024.

The EU's product licensing law **does the same**, and there are reports of **confidential liability clauses** in the contracts the EU signed with vaccine manufacturers.

The UK went even further, granting **permanent legal indemnity** to the government, and any employees thereof, for any harm done when a patient is being treated for Covid19 or "suspected Covid19".

## **6. DID YOU KNOW 99.8% OF PEOPLE SURVIVE COVID19?**

The case-fatality ratio of Sars-Cov-2 infection has been a bone of contention for months, but it is certainly much lower than all the initial models predicted.

It was originally massively inflated, with the WHO using a **figure of 3.4%**.

Subsequent studies have found it to be much lower, in some cases even lower than 0.1%. A report published in October in the WHO's own research bulletin finding a CFR of **0.23%** "or possibly considerably lower".
